Contract Description: This project includes the pavement rehabilitation to Runway 15L-33R at Milwaukee County's Timmerman Airport. The rehabilitation work involves milling 2" of approximately 45,000 SY of asphalt and replacing it with a 4" overlay in two lifts. Also included in the contract is temporary and permanent pavement marking and turf repair related to the asphalt work.
