 - a. **REVISE** 07 61 00, 1.8, B, as follows:

"Furnish:

- Special Warranty: Manufacturer's standard form in which manufacturer agrees to repair or replace components of metal panel systems that fail in materials or workmanship within specified warranty period.
 - a. Failures include, but are not limited to, the following:
 - 1) Structural failures including rupturing, cracking, or puncturing.
 - 2) Deterioration of metals and other materials beyond normal weathering.
 - b. Warranty Period: Two years from date of Substantial Completion.
- Special Weathertightness Warranty: Manufacturer's standard form in which manufacturer agrees to repair or replace standing-seam metal roof panel assemblies that fail to remain weathertight, including leaks, within specified warranty period.
 - a. Warranty Period: 20 years from date of Substantial Completion.
- 3. Special Panel Finish Warranty: Manufacturer's standard form in which manufacturer agrees to repair or replace metal panels that show evidence of deterioration of factory-applied finishes within specified warranty period.
 - a. Exposed Panel Finish: Deterioration includes, but is not limited to, the following:
 - Color fading more than 5 Hunter units when tested according to ASTM D 2244.
 - 2) Chalking in excess of a No. 8 rating when tested according to ASTM D 4214.
 - 3) Cracking, checking, peeling, or failure of paint to adhere to bare metal.
 - b. Warranty Period: 20 years from date of Substantial Completion."
