## Message from County Executive Walker

*On Wednesday, I vetoed the resolution to hold a referendum on a \$130 million tax increase.*

*At a time when fuel and food costs are so high, proposing a \$130 million is NOT the way to stimulate the economy. Furthermore, a \$130 million tax increase will make Milwaukee County into a tax island. Currently, Racine and Waukesha counties do NOT have a sales tax. If approved, this \$130 million tax increase would put our county a full 1.5% higher than our neighbors to the south and west. In addition, a major increase in the sales tax is likely to drive more people to make purchases on the Internet where there is not sales tax.*

*Supporters of the resolution on the \$130 million sales tax increase claim that it will lead to property tax relief. In 1991, members of the County Board said the same thing when they enacted the original .5% sales tax. From 1992 to 2002, property taxes went up 55%. History shows that property taxes will NOT go down but are overall tax burden will go up. Furthermore, lawyers for the county note that nothing in the resolution or referendum question can legally bind the County Board to provide property tax relief.*

*Bottom-line: we should work to add more jobs in Milwaukee County and this region and adding a \$130 million tax increase is not the answer. Working to protect our parks and improve our transit system through plans we have to add more hours of labor in the parks and to support transit through the use of our airport are better options - that do NOT raise taxes.*
