Procedures:

- 1) **ONLY** parents, grandparents, and/or legal guardian **with a photo ID** may visit. Stepparents may visit upon written verification from the assigned worker. No other family members are allowed visitation.
- 2) NO MINOR CHILDREN ARE ALLOWED
- 3) Juveniles are allowed one family visit per day.
- 4) Family visit is limited to two visitors.
- 5) After morning court, parents may visit with juveniles for five minutes, *if determined by Detention Staff.*
- 6) Family visitors **MUST** lock outer garments, pagers, cell phones, and purses in the lockers provided.
- 7) Professional Visits: After being screened, professional visitors are only allowed to bring in their outer garments, purses, and brief cases into the visitation area.
- 8) Non-visitors are **NOT** allowed to stay in the security area or elsewhere in the building.

All professional and family visitors:

- No items are **ALLOWED** to be brought to the visiting area (i.e.: Cellular/mobile phones, cameras, etc.).
- Taking pictures/video in the detention center is not allowed.
- No items are to be given to a youth (i.e: as candy, gum, or any other items).

ONLY THE DETENTION SUPERINTENDENT MAY AUTHORIZE ANY EXCEPTIONS
