

Court Worker Access to Wraparound Data on Synthesis

If youth is enrolled in Wraparound, you will see the youth's name twice on your enrollee list. The information you have accessible under the Wraparound client file is a bit different than what you see under the Childrens Court client file.

Forms – From Forms, you can:

1. see the Court letters written by the Care Coordinators (you get a login message when Wraparound approves the letter)
2. See the Permanency Plans written by the Care Coordinators (again you get a login message when Wraparound approves it)
- 3. Print a youth’s Plan of Care**

To see the court letters and permanency plans – just select which Form Type you want to view. After you select the Form Type, you’ll see a list of all that exist, as well as a link to print the Plan of Care and Crisis Plans.
