From the Director...

Changes in Badger Care Plus will Increase Eligibility for Enrollment in Wraparound Milwaukee

With the upcoming changes in the Affordable Care Act (ACA), there will be some changes in eligibility for Medicaid affecting children. While the Badger Care Plus income limit for parents, caretakers, and single adults is changing to 100% of federal poverty level, the income limits in Wisconsin for children are not changing. Instead, the children who are now in the Badger Care Plus Benchmark Plan, due to having income above 200% of the federal poverty level, will now be moved to the Standard Plan. Eligibility for the Medicaid Standard Plan is required for full Medicaid coverage, including enrollment in Wraparound

Milwaukee. In addition, there is one more group of children who will receive a 12 month CHIP (Children’s Health Insurance Program) extension in January 2014.

This will mean there will be more children eligible to enroll in the Wraparound Milwaukee program if they meet the other SED criteria. The estimated number of children moving to the Badger Care Plus Standard Plan from the Benchmark Plan in Milwaukee County is 2,804 children. This new eligibility goes into effect January 1, 2014.

Upcoming Site Visits to Wraparound Milwaukee

Wraparound Milwaukee will host site visits from groups from Ramsey County Juvenile Services from St. Paul, Minnesota, on July 10th to 11th, 2013, and from El Paso County, Colorado Springs, Colorado, on July 30th, 31st and August 1st, 2013.

Ramsey County is looking to develop an intensive care coordination component in their juvenile probation area and El Paso County is developing and implementing the State’s first Case Management Entity (CME) for youth with serious emotional and mental health needs and their families.

My name is Wendy Berger and my son is Christopher. Steven [Schmid] was Christopher's Care Coordinator. I'd like to take just a minute to let you know how things went with Steve. When Steve came into mine and Christopher's life, we were in turmoil and I didn't have a clue which way to turn. In hindsight, the best thing that could have happened to Christopher was to be arrested and sent to juvenile court. Without that happening, we would not have been able to be part of the Wraparound program and we would not have met Steve. Of all the people that were thrown at us during Christopher's year of probation, only two stood out and stuck with us to the end. Steve being number one. I know that it is his job to do what he did, but he did it with caring and compassion. No one else in the "system" cared or bothered with us (including his Probation Officer).

Steve was at our home every week without fail. He listened to our problems like he was a family counselor. He was a sounding board for us so that we could all heal together. He put effort into all of our meetings. He is professional with a personal side, which was easy for us to relate to. We liked him right off the bat. At first I wasn't sure how someone as young as he is was going to help us, but he did. Slowly but surely, not only did my son start to head down the right path, but the family as a whole started to come together.

I just want to say that Steve was the right person for us. He should be commended for the way he handles his "kids" and the families also. I believe that Steve has a bright future and whoever is in his path will be the better for it. It was emotional for me on our last day together. Not only because our support person was leaving, but because Steve
