## Milwaukee County Aquatic Centers, Outdoor Pools and Wading Pools Have Hours Extended Today

(Milwaukee, WI) Milwaukee County Executive Chris Abele announced that Milwaukee County Parks aquatic centers, outdoor pools and wading and splash areas will extend their hours on Sunday to help people cool off in the expected hot temperatures.

Cool Waters Family Aquatic Park in Greenfield Park, and David F. Schulz Aquatic Center in Lincoln Park will be open until 8 p.m. All Milwaukee County outdoor pools will have a night session from 5:30 p.m. to 7:30 p.m. including Grobschmidt, Hales Corners, Holler, Jackson, McCarthy, Pelican Cove, Sheridan, Washington and Wilson.

Wading pools and splash areas will also be extending their normal open times by two hours. Go to [countyparks.com](http://countyparks.com) to find a list of locations and normal time schedules of all wading pools and splash pads.

The county is closely monitoring temperatures and attendance at the parks' pools and aquatic centers during this week's expected high temperatures and will extend hours again as needed.

“A great way to enjoy this hot summer weather and stay cool is to take advantage of the extended hours at Milwaukee County Parks aquatic centers and pools,” Abele said. “While having fun outdoors, don’t forget to avoid overexposure to high temperatures, and please pay special attention to the needs of children and the elderly during this heat wave.”
