

Milwaukee County Court-ordered Huber Inmate Arrested After Crash in Wind Lake, Admits Heroin Use



Milwaukee, WI – The Milwaukee County Sheriff's Office Electronic Monitoring Unit (EMU) received a call from Racine County Dispatch at 5:35 p.m. yesterday that a Milwaukee County inmate on court-ordered Huber release had been arrested in Wind Lake.

Daniel Wojciechowski, age 23, was involved in a one-car crash in Wind Lake just before 5:00 p.m. He ran his car off the road, and had drug paraphernalia with him. Town of Norway police arrested Wojciechowski for Possession of Drug Paraphernalia and Operating a Vehicle Under the Influence and took him to the Racine County Jail. MCSO has placed a Probation and Parole hold on the inmate.

Wojciechowski was supposed to return to the Milwaukee County Correctional Facility-South at 4:45 p.m. from his job in Oak Creek. He admitted to the arresting officers that he had been using heroin prior to the crash.

Wojciechowski was in MCSO custody since May 2011 stemming from charges of Bail Jumping, Possession of Drug Paraphernalia, Possession with Intent and Cause Injury/OWI. His release date was set for August 25. Judge Clare Fiorenza sentenced him to Huber privileges in December 2011, despite back-to-back felony drug arrests in June and July 2010 and multiple non-appearances in court proceedings.

“Judicial leniency strikes again,” said Sheriff David A. Clarke Jr.

Please note in the criminal history below that the judges have repeatedly stayed the sentences for Wojciechowski and allowed him work-release privileges.

Criminal History – Daniel J. Wajciechowski:

- **05-16-2006** Arrested by Muskego Police Department for Possession Of Schedule I And II Narcotic (misdemeanor), Possession Of THC (misdemeanor), and Operating Under The Influence (non-criminal). In Waukesha County case number 2006CM002277, convicted and sentenced to have his license revoked for 6 months.
- **08-21-2007** Arrested by Muskego Police Department for Operating While Intoxicated (misdemeanor). In Waukesha County case number 2007CT002015, convicted and time served.
- **12-24-2009** Arrested by Oak Creek Police Department for Operating While Suspended (non-criminal). In Milwaukee County case number V313813-3, convicted and issued a fine.
- **12-26-2009** Arrested by Brookfield Police Department for Theft-Movable Property (misdemeanor). In Waukesha County case number 2010CM000018, convicted and sentenced to 6 days Waukesha County Jail.
- **06-12-2010** Arrested by Milwaukee Police Department for Possession With Intent Heroin (felony). In Milwaukee County case number 2011CF000319, convicted and **sentenced to 3 years** Wisconsin State Prison.
STAYED – probation 3 years, 6 months HOC with Huber.
- **07-19-2010** Arrested by Waukesha County Sheriff’s for 4 counts of Manuf/Deliver Schedule I And II Narcotics (felony). In Waukesha County case number 2010CF000675, convicted and **sentenced to 3 years** incarceration and earned release programs, 3 years extended supervision.
STAYED - 8 years probation, 6 months Waukesha County Jail.
- **08-30-2010** Arrested for Cause Injury/OWI. 2010CF004272, convicted and **sentenced to 5 years.** 3 years initial confinement, 2 years extended supervision.
STAYED –probation with DOC for 3 years, 12 months HOC with Huber.
- **08-18-2011** Arrested for Count 1: Bail Jumping, Count 2 Possession of Drug Paraphernalia. Count 1 **sentenced to 3 years** Wisconsin State Prison, initial confinement of 18 months.
STAYED, probation 3 years, 6 months HOC with Huber.
