Court-Ordered Huber Inmate Flees After Battery



Milwaukee, WI – The Milwaukee County Sheriff's Office is asking for the public's assistance in locating a court-ordered Huber release inmate who fled from custody last night after he allegedly beat his girlfriend.

There is a warrant out for the arrest of Ronald White, age 29, of Milwaukee. He is on court-ordered Huber release for AODA counseling. He was sentenced for Operating While Revoked, an OWI-3rd and an OWI-2nd. He had been in MCSO custody since August 15, on Huber since August 16. His release was set for January 30, 2013.

A warrant for Battery DV and for Escape from Custody has been issued.

"I question the wisdom of why a convicted inmate has to be released to get alcohol and drug treatment," said Sheriff Clarke. "That treatment is administered in house as an inmate program. There's no need to allow a Huber excuse for AODA counseling. The best place for him to get the treatment and keep the public safe – both of these are achievable – is to keep him locked up to serve his sentence while getting the treatment he needs.

Chief Judge Jeff Kremers, with his soft-on-crime philosophy, thinks that the only consideration is monetary cost. I strike a balance between cost and protecting the public, and will always err on the side of public safety. This inmate's girlfriend found out the hard way what can happen when cost is the only sentencing consideration."
