Suspect Strikes Correctional Officer in Booking Room



Milwaukee, WI – A suspect was brought into the Milwaukee County Jail today at 7:00 a.m. on two counts of Robbery/Use of Force. As part of the booking process, all property is taken from the subject and inventoried. The suspect, Deshazo Campbell, age 22, of Milwaukee, had a decorative gold grill (street vernacular) in his mouth and refused to remove it. Officers attempted to calm him down, when he threw several punches, striking a correctional officer in the face several times.

The correctional officer suffered a laceration above his eye, and cuts to his lip and hand. He was taken to Froedtert Hospital for treatment of his injuries. Campbell, in addition to his original charge, now faces a charge of Battery to Law Enforcement Officer, a Class H Felony which carries a sentence of up to six years in prison upon conviction.

Campbell's criminal history includes seven arrests, the last just two weeks ago:

12/13/11: Arrested by Milwaukee Police Department for (MISD) Operating after suspension/revocation.

04/13/12: Arrested by Milwaukee Police Department for (MISD) Battery and Criminal Damage to property.
