### Operation Drive Sober Results in 13 Arrests 1207 Repeat Offenders Since January 2010

Milwaukee, WI – At the start of last year, Sheriff David A. Clarke Jr. ordered an aggressive weekend Driving Under the Influence (DUI) initiative to rid the Milwaukee County freeway system of drunken drivers.

This weekend's initiative, from Friday at 4:00 p.m. through Sunday at 6:00 a.m., resulted in the arrest of thirteen drunken drivers, with two repeat offenders. The average PBT result was .12.

Repeat offenders, both for DUI-2<sup>nd</sup>, were Wendy Fuller, age 31, of Waukesha, and Anabel Aranda-Salazar, age 29, of Milwaukee.

A Cook County, Illinois Assistant District Attorney, Rachel Howland, age 29, of Milwaukee was cited for DUI-1<sup>st</sup>. A 911 caller reported that Howland's vehicle was all over the road and almost running vehicles off the freeway. Howland was stopped on I-94 northbound at S. 6<sup>th</sup> Street shortly before 2:00 a.m. She refused to perform field sobriety tests or PBT at the scene, but did submit to a chemical test of her breath at the substation. She had an intoximeter result of .11. Howland would not say where she had been drinking.
