

### Deputies Arrest 8 Drunken Drivers in Operation Drive Sober Woman arrested for felony DUI-5<sup>th</sup> offense 1307 Repeat Offenders Since January 2010

Milwaukee, WI – Sheriff David A. Clarke Jr. has ordered a continued aggressive weekend Driving Under the Influence (DUI) initiative to rid the Milwaukee County freeway system of drunken drivers. This weekend's Operation Drive Sober initiative, from Friday at 4:00 p.m. through Sunday at 6:00 a.m., resulted in the arrest of eight drunken drivers, four who were repeat offenders. The average PBT result was .14.

Repeat offenders included Kelly Harkins, age 29, of Pell Lake, who was arrested for DUI-5<sup>th</sup> offense; Jimmie Turner, age 40, of Kenosha, for DUI-4<sup>th</sup> offense; Carlton Morgan, age 56, of Milwaukee, for DUI-3<sup>rd</sup> offense; and Robert Bromberek, age 34, of Milwaukee, for DUI-2<sup>nd</sup> offense.

First-time offenders were Milwaukee residents: Nathaniel Townsend-Fath, age 19; Shavonna Brown, age 21; Lydia Smith, age 30; and Petou Vang, age 31.

#### DUI-5<sup>th</sup> Felony Offense:

At about 3:45 a.m., a deputy stopped a vehicle in the 1700 block of W. Canal Street for lane deviation. The driver, Kelly Harkins, tested a .067 on the PBT, but due to four prior convictions for drunken driving, can not have a PBT above a .02.

**Harkins said she had one glass of wine at a baby shower in Kenosha. Deputies found a crack pipe with white residue in her purse. Harkins also had a valid warrant with Walworth County for Failure to Appear.**

**If convicted of the DUI-5<sup>th</sup> offense, Harkins faces up to six years in prison. Her prior convictions were in February 2004, April 2008, July 2010, and June 2011.**
