### Deputies Arrest 14 Drunken Drivers in Operation Drive Sober Man Arrested for DUI-9<sup>th</sup>

Milwaukee, WI – Sheriff David A. Clarke Jr. has ordered a continued aggressive weekend Driving Under the Influence (DUI) initiative to rid the Milwaukee County freeway system of drunken drivers. This weekend's Operation Drive Sober initiative, from Friday at 4:00 p.m. through Sunday at 6:00 a.m., resulted in the arrest of 14 drunken drivers. The average PBT result was .15.

Deputies arrested three repeat offenders. Russell Starzman, age 54, of West Allis, for DUI-9<sup>th</sup> offense, Nicholas Russell, age 28, of Milwaukee for DUI-2<sup>nd</sup>/Causing Injury/While Armed, and Martin Arvizu, age 30, of Milwaukee, for DUI-2<sup>nd</sup>.

Russell Starzman, age 54, of West Allis, was arrested for DUI-9<sup>th</sup> offense after deputies responded to a call about a reckless driver on I-41 to I-94 westbound on Saturday shortly after 4:00 p.m. The caller indicated the driver exited at Highway 100, and deputies arrested Starzman outside his home near 104<sup>th</sup> and Greenfield Avenue. His PBT was .29. Records show his drunken driving convictions for 5<sup>th</sup> offense in February 1999, 6<sup>th</sup> and 7<sup>th</sup> in February 2004, and 8<sup>th</sup> in 2006.

**This morning at 2:20 a.m., deputies responded to a crash on the I-94 off ramp to north Hawley Road. A Toyota Corolla, driven by Nicholas Russell, age 28, of Milwaukee, went through a red light and struck a Dodge van that was exiting the off ramp. The 55-year-old driver of the van suffered a laceration to her head and a possible broken arm and was transported to the hospital. Russell tested a .24 on the PBT and was arrested for DUI-2<sup>nd</sup> offense, DUI-Cause Injury, and Go Armed While Intoxicated.**
