Operation Drive Sober Results in Nine Arrests 1815 Repeat Offenders Since January 2010

Milwaukee, WI – Acting Sheriff Richard R. Schmidt ordered an aggressive Operating While Intoxicated (OWI- drugs and/or alcohol) initiative to rid the Milwaukee County freeway system of intoxicated drivers. This weekend's Operation Drive Sober initiative from Friday at 4:00 p.m. through today at 6:00 a.m., resulted in the arrest of nine drunken drivers. The average PBT test results were .16.

Two repeat offenders were arrested: Adon Castaneda, age 34, of Woodstock, Illinois; and Keuane Gilbert, age 34, of Milwaukee.

First-time offenders taken into custody were: Rachael Kohler, age 21, of Brookfield; Charles Wallander, age 36, of Menomonee Falls; Ranzell Bedford, age 41, of Greenfield; Jason Williams, age 45, of Bellwood; and Milwaukee residents: Matthew Kuehn, age 24; Dana Imanski, age 55; and Robyn Recore, age 29.

Freeway crash- OWI-4th

Adon Castaneda was involved in a two-car personal injury crash on Friday afternoon at the start of the east-to-south ramp westbound I-94 in the stadium interchange. Both vehicles struck the attenuator barrels in the gore area of the ramp. Castaneda struck the other vehicle while attempting to change lanes. His PBT result was .26, and he was arrested for OWI-4th. His previous OWI arrests were in 2002, 2004 and 2010.

Motorcycle crash at Grant Park

Dana Imanski was involved in a serious personal injury crash at about 1:45 p.m. on Saturday at Grant Park by the beach. Cudahy and St. Francis police and South Milwaukee Fire Department also responded to locate the crash scene.

The 911 caller indicated the motorcycle came around a corner into her lane of traffic at a high rate of speed, the rider lost control and she saw him go off the roadway and over the edge of a steep hill.

The motorcycle came to a stop at the bottom of a hill, and Imanski was found about 20 feet away. He was breathing, but unconscious. Firefighters carried him up the hill to meet Flight for Life by the golf course clubhouse. He is expected to survive his injuries.
