### Milwaukee County Parks Partners with the Philippine Community Center at Zablocki Park Pavilion

Filipino-Americans of Milwaukee are thankful and welcome the opportunity to give back to the community and in doing so opened the Philippine Center Free Medical Clinic at Zablocki Park. The clinic serves thousands of people a year who are either under-insured or not insured by health insurance. Funding for the Center is independent and separate from the operating funds of the Philippine Center, and comes from grants and donations from private individuals and pharmaceutical companies. All services are provided free by volunteers and donors, including 45 licensed physicians.

The Philippine Community Center opened this past year along with its Free Medical Clinic at the Zablocki Park Pavilion. Philippine Center Executive Director Gerry Ramos and Free Medical Clinic Director Dr. Violeta Singson, along with Zablocki Park Manager Dan Roddy, welcomed major improvements to the Zablocki County Park Pavilion. The revitalized Pavilion will also be home to classes such as: Filipino Cooking, Language and Dance classes, as well as Youth activities and Workshops for children.

The clinic is located in the Zablocki Park Pavilion on 3717 W. Howard Ave.

### Harley-Davidson Donates \$2.4 Million to the Hunger Task Force Farm

Supervisor Borkowski was on hand for the event that kicked off the historic partnership between the Harley-Davidson Foundation and the Hunger Task Force Farm that will fund a signature program in the amount of more than \$2.4 million through 2016.

Support from the Harley-Davidson Foundation will allow the Hunger Task Force to operate a unique urban farm in Franklin for the next three years.

Since 2004 Hunger Task Force has operated the 208-acre urban Farm and Fish Hatchery through a public private partnership with Milwaukee County. The Farm and Fish Hatchery is owned by Milwaukee County and is part of its parks system. It is operated by Hunger Task Force under the terms of a 30-year lease with Milwaukee County. As part of its lease, Hunger Task Force also operates the Milwaukee County Park system fish hatchery. Game fish raised in the hatchery are released in Milwaukee County Park ponds for recreational fishing. The Farm is used for the express purpose of raising fresh, nutritious food to feed hungry people in Milwaukee County.

Hunger Task Force and The Harley-Davidson Foundation have partnered for more than twenty years. The support from Harley-Davidson Foundation not only will improve the quality of life of many people in Milwaukee, but also supports job training to low-income residents of Milwaukee and educational and agricultural programs to Milwaukee Public School children.

Supervisor Borkowski and Milwaukee County thank Harley-Davidson Foundation for their generous donation to Hunger Task Force, and continued support and partnership of the Hunger Task Force Farm.

- 60 years or older (American Indian seniors who are 55 years or older)
- Residents of Milwaukee County
- Have Monthly income of less than \$1,723 for a family of one.
- Have Monthly income of less than \$2,233 for a family of two.

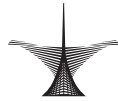
