### DREXEL INTERCHANGE GROUNDBREAKING

On May 7, Supervisor Taylor joined Governor Scott Walker, State Transportation Secretary Mark Gottlieb and other state and local officials in breaking ground for the I-94 interchange at Drexel Avenue in Oak Creek.

The interchange will play an important part in increasing economic development in the cities of Oak Creek, Franklin and surrounding communities. It will allow for better access to area businesses and institutions, including the nearby Northwestern Mutual campus and the new Delphi plant.

The total project cost is \$13 million. Construction will commence later this month and is expected to be completed by November of 2012.

#### I-794 EXTENSION PROPOSAL

Last month Supervisor Taylor co-sponsored a resolution endorsing the recommendation of the Lake Parkway Study Advisory Committee to extend the Lake Parkway (State Trunk Highway 794) to Highway 100 in Oak Creek.



The Milwaukee County Board of Supervisors approved the resolution requesting that an extension of the Lake Parkway from Edgerton Avenue to Highway 100 be added to the regional transportation system plan by the Southeastern Wisconsin Regional Planning Commission and the Wisconsin Department of Transportation. They will conduct necessary preliminary engineering and environmental impact studies for the project.

Extending this stretch of road would be a tremendous asset to South Milwaukee, Oak Creek, Franklin and surrounding Milwaukee County communities as it provides an alternate access to the south side of the City of Milwaukee and downtown.

### "CHAT WITH THE CHAIR" IN FRANKLIN

On June 6 Supervisor Taylor hosted Milwaukee County Board Chairwoman Marina Dimitrijevic at Franklin City Hall as part of her "Chat with the Chair" listening sessions – a series of town hall meetings intended to improve communication between all Milwaukee County municipalities and Milwaukee County government, while exploring ways to work together in solving common problems.

Chairwoman Dimitrijevic heard from Franklin residents on many important issues, including the poor condition of county roads, taxes, the future of the Downtown Transit Center and the War Memorial, as well as the possibility of opening a county-run senior center in Franklin.

# MILWAUKEE COUNTY SPORTS COMPLEX PARKING LOT REPAVEMENT

As you may have already noticed, the Milwaukee County Sports Complex parking lot is being repayed. The work began on June 4th and the project is scheduled to be completed by August 17, 2012.



The Milwaukee County Department of Public Works intends to complete the existing asphalt portion first before starting on the gravel portion of the lot. Approximately half of the parking lot remains open during construction.

### STEVE F. TAYLOR GOVERNMENT SCHOLARSHIP

Earlier this year, Supervisor Taylor proudly announced the first winner of the Steve F. Taylor Future Leaders of Franklin Scholarship. With his own personal funds, Supervisor Taylor has awarded a \$500 scholarship to Charlotte Kanyuh, a Junior at Franklin High School. Charlotte is interested in studying political science and law, and last year she participated in the United States Congressional Page Program.

Scholarship applicants were asked to write about the qualities of a good public servant and why public service is important to the community. Each applicant also went through a short interview. Franklin Municipal Judge and Former Mayor Fred Klimetz participated in the review and selection process.

The award will be offered annually in the spirit that young people are our future, and it is important to begin grooming a generation of leaders early on. ### DISTRICT 9 INFRASTRUCTURE MAINTENANCE PROJECTS

Immediately upon taking office, Supervisor Taylor called a meeting with city and village engineers from all three municipalities located in the 9th District and Milwaukee County Department of Transportation and Public Works Director Frank Busalacchi to discuss outstanding County-related public works issues. Among the most pressing issues cited were the need for dredging of the boat launch pad in Bender Park, a collapsed culvert at the entrance of Hales Corners Park, as well as several concerns with roadways the county maintains in these municipalities.

With respect to dredging at Bender Park, the County expended over \$200,000 for dredging of the launch pad in 2011, and the fix was to last for about five years. Unfortunately, due to an extremely mild winter and other weather conditions, the sediment that was removed piled back up in the basin to the extent that new dredging is required to make the launch pad usable. The Milwaukee County Parks Department is in the process of securing a permit, as well as looking at the price estimates, to dredge. Look for updates on this matter in the July e-Newsletter.

Concerning the collapsed culvert in Hales Corners Park, while the jurisdiction on this matter lies with the Village of Hales Corners, the Milwaukee County Parks Department is assisting in getting estimates on the repair costs. Construction may begin this summer, pending available funding and the Hales Corners Village Board approval.
