Our Regional Cultural Assets Need Regional Support

I am a member of the Metropolitan Milwaukee Association of Commerce's 48-member Committee on Cultural and Entertainment Capital Needs, which is holding a series of public meetings to determine how to best serve the needs of the region's arts, entertainment and cultural institutions.

This discussion will greatly affect the future of our community for decades, and it is important I get the chance to listen to the residents of our county about their vision for our cultural, recreational and entertainment amenities.

While much of the attention in this discussion has been focused on the need for a new downtown arena, the issue is much bigger than just one building.

Milwaukee County has a long, proud tradition of being a

major supporter of parks, recreation and the arts. However, we cannot do it alone. These regional assets need regional support from our partners in other counties. Milwaukee County residents voted in support of dedicated public funding for parks, culture and transit via an advisory referendum in 2008. I am excited to be at the table of this important discussion and plan to have an open mind with a vision for moving our region forward.

I have held a series of "Coffee & Culture" chat sessions at county-supported amenities so that I can get input from everyone on these important cultural and entertainment issues.

Board Approves Green Proposal for Mitchell Airport Solar Farm

The Milwaukee County Board recently passed my resolution to study the feasibility of a new solar project at Mitchell International Airport. The vote to approve was 16 to 2.

The positive endorsement of my green power-green jobs legislation is an important step toward increasing the use of renewable energy in Milwaukee County.

With the cost of solar panels becoming more economically feasible, now is the time to think big in Milwaukee County. Other airports around the country have installed similar solar farms and have seen great energy savings.

Solar energy helps protect Wisconsin's natural resources and advances the energy efficiency and renewable energy provisions of Milwaukee County's "Greenprint" initiative while supporting Wisconsin's goal of using 10 percent renewable energy by 2015.

I introduced the "Greenprint" initiative and it was passed in 2007. It was expanded in 2009 to include a Sustainability Director to oversee the initiative. Milwaukee County has saved taxpayers money by reducing energy consumption and improving our county-wide infrastructure.

I am excited about the prospect of using solar energy, not only to save energy, but to save valuable resources.

It's Time to Move Forward on Transit

Recently I joined three other County Supervisors in asking the County Executive to issue a new bid for transit in Milwaukee County. It is critical that a new bid be issued as soon as possible.

The residents and employers of Milwaukee County expect a dependable transportation system, and we have a duty to ensure a responsible process is used to protect the public and provide the community with the best value.

An appeal ruled the original bid process was flawed, and the County Executive's administration can correct the mistakes with a new bid.

The time is now for the County Executive and the County Board to come together and find the best way to move forward. Public transit is vital to growing our local economy, and we are looking for the most efficient, modern, and reliable way for our residents to get around our county.

Improving South Shore Beach

The County Board passed my budget amendment that dedicates County resources toward cleaning up South Shore Beach. South Shore Beach is an important gathering place in our community, and we need to continue our efforts to clean up the beach for everyone to enjoy.

Under the amendment, funds will be used by the Parks Department to purchase a beach groomer to clean the sand along the South Shore. In addition, planning and phase 1 designs will begin soon to reconstruct the South Shore Yacht Club parking lot, which needs repair and is contributing to runoff polluting the water. By replacing the current pavement with permeable pavement, runoff will be reduced and the water quality will improve.

We are moving in the right direction on South Shore Beach clean-up, and I will continue my efforts to ensure that the beach is a pleasant and enjoyable place for family gatherings or just for quiet contemplation.

When the winter thaw takes place, our efforts to move forward on South Shore Beach clean-up will continue.

Board Approves Living Wage

The County Board in February passed a County living wage of \$11.32 by a veto-proof majority of 12-6. The living wage would affect employees of contractors who do business with the County.

The living wage is meant to raise people out of poverty by paying them a wage equal to federal poverty level for a family of four. Right now, with a minimum wage of \$7.50, many people with full-time jobs are forced to live in poverty, and often they must seek public assistance to get by.

President Obama called on local governments to act on a minimum wage if Congress did not. We acted. Now it's time to move forward.

Growing poverty, foreclosed homes and hungry families are the very things that are tearing down this community. A living wage can help to address these problems of income inequality in Milwaukee County.



We could not wait for state action. We could not wait for federal action. We needed County action.

People working in full-time jobs should not be forced to live in poverty. That's why I will continue to support a living wage as we move forward.

Improvements Coming to Pulaski, Noyes Indoor Pools



As you may already know, my amendment to the 2014 County Budget kept open the Pulaski and Noyes indoor swimming pools and provided funding for improvements. Some of the funding for repairs also came from a generous donation from Mr. Stanley Kass of Brown Deer. The pools are now open for everyone to enjoy, especially during this harsh winter.

Here is a brief summary of what's happening with the two pools.

- New roof Request for Proposals are going out and a

replacement roof is expected to be in place this year.

 A revitalized Friends group is expanding and growing, looking to add value to participation and recognition of the pool and what it offers to the community.


-Pulaski
