Budget Season Commences

On September 29, the County Executive presented his Recommended 2012 Budget, available at http://county.milwaukee.gov/FiscalAffairs7904/2012-Recommended-Operating-Bud.htm. He articulated his goals to maintain services for the most vulnerable, preserve quality of life, pay down debt and not increase taxes.

County Executive Abele indicated his priority to keep transit. He will continue efforts to redesign the mental health system to a community-based model. His budget would restore 18 of 28 positions that were lost as a result of the State's cuts to Child Support Enforcement funding. The Executive will support \$1 million for pretrial screening, known as Universal Screening.

I think the County Executive hit the correct priorities while still holding the line on property taxes, which are too high. Of course, the devil is in the details, and we will spend all of October reviewing. I do not agree with the County Executive's proposal to remove support for Emergency Medical Services. I look forward to a productive budget session in which the Executive works with the Board for the good of Milwaukee County residents.

The Finance & Audit Committee will consider the recommendations and make amendments, beginning on October 10. I will closely follow these budget hearings and offer suggestions. Transit

The Milwaukee County Transit System has been dealt a 10% (\$6.8 million) cut in State funding. This forced the system to propose service cuts that would have hurt our South Shore.

Many South Shore constituents testified about the impact of initial proposed cuts at a September 13 meeting at Cudahy Library. Hearing the concerns of residents and businesses loud and clear, I urged our County Executive to preserve Route 15, Flyer

and paratransit service.

I am relieved that County Executive Abele's proposed budget does not eliminate Freeway Flyers. I will be investigating how his proposed Express Route 15 would impact current service. I am hopeful that our County is able to secure federal funding during the month of October which would allow us to preserve service.

The 2012 Executive Budget relies on various sources of federal money as well as health care efficiencies that must be studied for liability issues. However, if the federal monies do not materialize, the County Executive has recommended relying on initial proposals (elimination of Freeway Flyers and restructuring of Route 15).

The County Executive's version of the budget will preserve County-wide paratransit van service for County residents who are elderly or have a disability that prevents them from using the bus. However, budget pressures have led the County Executive to recommend a paratransit fare increase from \$3.25 to \$4.50.

Emergency Medical Service

The County Executive's Recommended 2012 Budget would eliminate the \$3 million subsidy to the Emergency Medical Services (EMS) partnership with the municipalities.

This would hurt our South Shore district. The EMS program allows South Milwaukee to serve its own residents and Cudahy residents. Without the subsidy, that city will not be able to provide EMS services. The City of Milwaukee currently provides EMS service to St. Francis which would also be eliminated if the County Executive's proposal is adopted. Oak Creek stands to lose EMS funds from the County as well.

Family Care

The State has imposed an enrollment cap on Family Care. This program has allowed frail elderly citizens as well as residents with physical or developmental disabilities to receive care and live independently in the community since 2002. Family Care saves money by avoiding more costly nursing home care. Unfortunately, the State has now created a waiting list.

The problem in our community arises from the fact that our County tested a pilot program. Because it was successful, many nursing home beds were lost since individuals could use program money on less costly alternatives such as assisted living. Now, with waiting lists in Family Care, individuals are forced to go into nursing homes

on Title 19, but many of these beds are now gone.

Behavioral Health

I successfully introduced an amendment to a proposal for replacing Milwaukee County's mental health facility at the medical complex on Watertown Plank Road with a downsized facility. I was concerned that legislation offered by the New Behavioral Health Facility Study Committee primarily focused on constructing a new building. The treatment of patients and mental health redesign should drive the discussion, not the construction of a building.

My amendment directs the Interim Director of the Department of Health and Human Services to explore appropriate alternatives to the County owning a mental health facility. The Committee itself had initially recommended public/private partnerships. These should be considered along with leasing or build/lease options. Care provided in the current facility is ineligible for federal reimbursement, so we should consider care alternatives that qualify for reimbursement.

War Memorial Audit

Milwaukee County's Department of Audit released an enlightening report evaluating the Milwaukee County War Memorial Center. In 2010, I had authored a resolution requesting this facility and space needs audit in light of concern over needed repairs and upgrades of the structure.

The report revealed water infiltration and moisture-related problems; parking collection issues; and an antiquated governance structure.
