

# **INDOOR POOL PARTY ROOMS AT NOYES & PULASKI POOLS**

## **GUIDELINES & PROCEDURES**

Milwaukee County Pool Party Room rentals are available during Public Swim for family gatherings and **private** parties. **Rentals for which the general public would be invited are PROHIBITED.**

**Time of Use:** The Pool Party Room, off the pool lobby, is available for private use from 1:30–4:30 p.m. No guests will be admitted before 1:30 p.m., and all guests must leave the building by 4:30 p.m. **Decoration, setup and cleanup by the Renter / Permit Holder must be completed between 1 p.m. and 5 p.m.** If the building is not vacated by 5 p.m., You will be invoiced **\$50 for every 30 minutes past the rental time.**

**Number of Guests:** A maximum of 10 guests are allowed, two of which must be adults who supervise children in the group at all times. Pool admission for the 10 guests, regardless of age, is included in the rental fee. No additional admissions may be purchased at this time due to capacity restrictions. Not recommended for groups with children under 42" tall.

**Rental Fee:** The rental permit fee, (\$80 including tax), **must be paid at the time of reservation.** Admission to the Party Room will only be allowed if payment has been received by Milwaukee County Parks Aquatics Office. **Cash and credit card are the only accepted forms of payment.**

Milwaukee County Parks understands that the best plans may change. See Cancellations / Refunds below.

### **GUIDELINES, RULES & REGULATIONS**

All guests must follow the rules, regulations, and requests of Milwaukee County Lifeguards and pool staff. **NO REFUNDS MADE FOR CONSEQUENCES OF NON-COMPLIANCE.**

The Pool Party Room Rental Permit is subject to all local municipal and county ordinances in addition to all rules and regulations governing parks and parkways; the permit can be terminated immediately at the discretion of local law enforcement authorities and/or the Milwaukee County Parks Department, if the terms of the application are misrepresented, violated or when public safety is threatened. Cancellation of the permit for cause will result in forfeiture of all fees. **The person responsible for the rental must be 18 years of age or older.**

1. **ADVERTISING:** Pool Party Room rentals are available for family gatherings and **private** parties. **Any social media public posting or advertising to the general public is PROHIBITED.**
2. **ALCOHOLIC BEVERAGES:** No alcoholic beverages may be brought into and/or consumed within the pool building.
3. **AMPLIFIED SOUND/MUSIC:** DJ's and sound systems are **NOT ALLOWED** in the pool building. Only the public radio station playing within the pool area is allowed.
4. **CANCELLATIONS / REFUNDS:** All cancellations must be made in writing and submitted to the Aquatics Office by sending an email to: [APARKS@milwaukeecountywi.gov](mailto:APARKS@milwaukeecountywi.gov). If your cancellation is received within:
  - 24 hours of making your initial booking: **full refund**
  - 90 days or more prior to the scheduled rental date: **full refund minus a \$20 processing fee**
  - 89 to 30 days prior to the scheduled rental date: **50% refund**
  - less than 30 days prior to the scheduled rental date: **no refund**
5. **CHILDREN:** All children in the group must be supervised by adults in the group, throughout the building, including but not limited to the pool and pool deck, Party Room, lobby, and locker rooms. Small children must be accompanied by an adult in the water. Children may be asked to take a swim test before entering the deep end of the pool and using diving boards. Pool parties are not recommended for groups with children under 42" tall.

6. **CLEANUP / DAMAGE:** You are responsible for the restoration of the facility to its original condition by the end of the permitted rental period; this includes the removal of all decorations, including masking tape, and clearing the tables and counters of all perishables, etc. If excessive cleanup or damage occurs, you will be invoiced for the work required to bring the facility to its original condition.
  
7. **COVID REGULATIONS:** All guests entering the facility must adhere to the posted guidelines and current Milwaukee County Administrative Order.

  - If you or any guests display any COVID symptoms within the 2 weeks prior to the event, do not attend.
  - All guest over the age of 3 years must wear a mask when in the facility (including lobby, Party Room, locker rooms, bathrooms, etc.)—unless they are in the pool.
  - Maintain physical distancing; stay 6 feet apart.
  - Come prepared to swim and limit items brought into the facility and onto the pool deck.
  
8. **DECORATIONS:** Use only fireproof decorations and affix them with masking tape. **NO TACKS OR NAILS** of any kind are permitted. Use decorations that will not cause damage to the park property and remove all decorations before the end of your rental. **The use of confetti or any confetti-type material is PROHIBITED.**
  
9. **FLOTATION DEVICES:** Coast Guard approved floatation devices may be used in the shallow end of the pool within arm's reach of an adult.
  
10. **FOOD & BEVERAGES:** At this time, only cake/desserts and non-alcoholic beverages are allowed. No refrigeration or coolers are available for your food and beverages. Food or drink is only allowed in the Party Room. No food or drink is permitted in the pool area, locker rooms, or lobby area. The rental permit does NOT allow sales of food or beverages.
  
11. **GIFT OPENING:** You may bring and open gifts at the Party Room, but Milwaukee County Parks is not responsible for the storage or security of your belongings. We suggest that one member of your group stay in/near the Party Room to watch belongings.
  
12. **INDEMNITY:** Renter(s) agrees to indemnify, defend, and hold harmless, the County, its officers and employees, from and against all loss or expense including costs and reasonable attorney's fees and/or liability for damages for personal injury and property damage to the extent caused by any negligent or willful act or omission of Renter(s).
  
13. **PARKING:** Parking lots are available for use by all park patrons.
  
14. **RESTROOMS:** All restroom facilities are available for use by all park patrons.
  
15. **TABLE & CHAIR SETUP:** Tables and chairs will be set up by the Parks Department at your request, at no charge.
