



**MILWAUKEE COUNTY DISABILITIES SERVICES DIVISION UPDATE IN RESPONSE TO CORONAVIRUS (COVID-19)** Issued: March 16, 2020

The Milwaukee County Disabilities Services Division is committed to the safety and needs of children and adults with disabilities. We are taking the current situation with the Coronavirus (COVID-19) very seriously and working closely with public officials and community partners to create plans for responding to this emerging situation.

**The following are the changes in service at this time:**

- **Disability Resource Center:** To minimize possible transmission of the virus, we are suggesting consumers to call our Disability Resource Call Center at (414) 289-6660 if you have questions or need assistance with:

- **Birth to 3/CLTS/CCOP:** To minimize possible transmission of the virus, we are suggesting consumers to call our Children's Intake line at (414) 289-6799 if you have questions or concerns about:
