BID 2018-13 Surplus Transit Buses

Issue Date: May 4, 2018

Milwaukee Transport Services (MTS), operator of the Milwaukee County Transit System (MCTS), is a quasi-governmental instrumentality of Milwaukee County. MTS is selling several New Flyer 40' low floor diesel transit buses as surplus. These buses are considered non-runners. Sealed bids must be submitted to the Milwaukee Transport Services, (MTS), at the above address on or before:

2:00 P.M. CST – May 29, 2018

Bids will be publicly opened and read at the above opening date and time in Room 104 of the Administration Building- Materials Management Department. Late proposals will not be opened or accepted for evaluation. Any proposals received after the established due date and time at the place designated for receipt of proposals is late, without exception.

Sale Location: Milwaukee Transport Services, 1525 W. Vine Street, Milwaukee WI 53205

Items for Sale: Several 40' low floor New Flyer diesel buses. These are all non-runners. Reserve price must be met. **A walk through to view all the buses will be held on May 16, 2018 at 10:00. Meet at the Fleet Maintenance building conference room located at 1525 W. Vine St**

Payment Deadline: Seventy-two (72) hours after award. Check should be made out to Milwaukee Transport Services and delivered to Stephanie Baker in room 104 of the Administration Building at 1942 N. 17th Street.

Removal Date: Within ten (10) Days after verified Receipt of Payment

How to Bid and Award of Contract: Bids for purchasing the surplus buses must be received on the bid form by the Materials Management Department at the above address, and above date/time. This will be awarded by line item to the highest price.

Bidder shall be responsible to obtain all documents pertaining to bid via the website: <http://www.ridemcts.com>. No verbal responses or questions from any agent of MTS shall be acted upon.

Removal of Printing Equipment: The successful bidder shall accept the equipment in "as is" and "where is" condition, with all faults, and shall make payment within seventy-two (72) hours after award. Removal shall occur within ten (10) calendar days after payment. If payment is not made within the seventy-two (72) hours after award, the next highest bid will receive the award. There shall be no

exceptions. The buses cannot be driven off of MTS property. Bidders must arrange for removal of buses. MTS is not responsible for the cost of removal. Persons attending during exhibition, sale or removal of goods assume all risks of damage of or loss to person and property and specifically release MTS and Milwaukee County from liability therefore.

Questions: The deadline for questions related to this sale is May 22, 2018 at 4:30 pm CST. All questions must be submitted in writing to sbaker@mcts.org.

Waiver of Informalities: In its sole discretion, MTS may waive informalities or minor irregularities in proposals received.

Binding Contract: A proposal received in response to this BID is an offer that can be accepted by Milwaukee Transport Services, Inc., to create a binding contract without negotiation with any bidder or company.

General Conditions:

1. Bids received will be publicly opened, read and recorded.
2. Offers to purchase the buses must be made on bid sheet and, the Signature Sheet must be signed by the bidder or his/her responsible representative.
3. It is the responsibility of the buyer to conduct proper checks and inspect the property thoroughly beforehand, for the buyer shall be regarded as having inspected and accepted the property in its actual state and condition once the bid is accepted.

4. INDEMNIFICATION:

Buyer shall indemnify and hold harmless Milwaukee Transport Services, Inc. and Milwaukee County, their agents, servants, employees and assigns, from and against any and all losses, expenses, demands, claims and liabilities on account of injury or sickness, including death, to persons, including employees of Milwaukee Transport Services or Milwaukee County, or for damage to property actual or alleged whether caused by the sole negligence of Milwaukee Transport Services Inc., Milwaukee County or their agents, servants, employees and assigns, the concurrent negligence of buyer and Milwaukee Transport Services, Inc. or Milwaukee County, or their agents, servants, employees and assigns, or any other person or otherwise arising out of, resulting from , or in any way connected with the sale, purchase, operation, maintenance, use, transportation or disposition of the above listed scrap parts. Buyer agrees to defend any suit, action or cause of action brought against Milwaukee Transport Services, Inc., Milwaukee County or their agents, servants, employees or assigns based on any such alleged injury, death, sickness or damage and to pay all damages, costs, and expenses including attorney fees, in connection therewith or resulting therefrom.

5. MTS reserves the right to reject any and/or all bids, if it is deemed in its best interest.
6. Submitting a bid implies that the bidder has read and accepts all the General Conditions. All responses must be returned in a sealed envelope provided by bidder with bid number clearly marked and received by the due date and time at the address listed above.
