RESULTS FROM MILWAUKEE COUNTY BOARD MEETING: MARCH 20, 2014

- 16-2 (No: Alexander, Weishan) to table a resolution authorizing and directing the Office of Corporation Counsel to coordinate with outside counsel on filing an action for a declaration of rights in property to obtain a judgment determining the extent of the County's title and rights to the Downtown Transit Center property. (Item 1)
- 14-4 (No: Alexander, Borkowski, Staskunas, Taylor) to override a veto of a resolution in support of federal and state legislation to raise and index the minimum wage. (Item 64)
- 12-6 (No: Alexander, Borkowski, Jursik, Schmitt, Staskunas, Taylor) to override a veto of a resolution/ordinance enacting a minimum living wage ordinance to service, concession, lease and financial assistance agreements publicly funded by Milwaukee County and amending Chapter 32.09 (17) of the Milwaukee County Code of General Ordinances. (Item 65)
- 15-3 (No: Alexander, Schmitt, Staskunas) to override the veto of a resolution to extend the time to negotiate an Intergovernmental Agreement between the City of Milwaukee and Milwaukee County for the operation and regulation of taxicab service. (Item 66)
- 11-7 (No: Alexander, Borkowski, Jursik, Lipscomb, Schmitt, Staskunas, Taylor) on a resolution authorizing and directing the rehiring of former displaced County housekeepers to service the Courthouse facility. (Item 13)
- 15-3 (No: Mayo, Schmitt, Stamper) on a resolution authorizing and requesting the Director of Audits to initiate an audit of the operations of the Boerner Botanical Gardens. (Item 14)
- 15-3 (No: Alexander, Mayo, Rainey) on a request from the Department of Parks, Recreation and Culture requesting authorization to transfer approximately 1.7 acres of land that is a remnant of the former Underwood Creek Parkway and to utilize proceeds from the land transfer to finance Veterans Park Pavilion and Restroom Project and Federal Emergency Management Agency 2010 Flood Related improvements. (Item 31)
- 16-1 (No: Jursik; Excused, Cullen) to request authorization to enter into a building lease agreement with Lake Tower Trains and Hobbies for the lease of approximately 650 sq.ft. of space at 215 E. Boden St. at Milwaukee County's Regional Business Park at General Mitchell International Airport for an initial term of three years beginning March 1, 2013. (Item 55)

- 16-1 (No: Weishan, excused, Cullen) a request for authorization to reallocate Community Development Block Grant funds to the Dept. of Parks, Recreation and Culture in an amount of \$245,790 for the renovation of the Sheridan Park Pavilion. (Item 60)
