MINIMUM LIMITS

Wisconsin Workers' Compensation

Statutory Limits*

* Workers' Compensation is required for all Providers, regardless of organizational structure or size (includes one-employee providers, sole proprietorships, partnerships as well as Providers composed solely of independent contractors).

A **Waiver of Subrogation** for Workers' Compensation by endorsement, "**In favor of Milwaukee County**" is also required. A copy of the endorsement shall be provided.

Commercial General and/or Business Owner's Liability

Bodily Injury & Property Damage \$1,000,000 - Per Occurrence

(Incl. Personal Injury, Fire, Legal Contractual & Products/Completed Operations) \$2,000,000 - General Aggregate

A **Waiver of Subrogation** by endorsement for Commercial General and/or Business Owner's Liability "**In favor of Milwaukee County**" is also required. A copy of the endorsement shall be provided.

Business Automobile Liability

Bodily Injury & Property Damage \$1,000,000 Per Accident

All Autos - Owned, Non-Owned and/or Hired And/or, Uninsured Motorists Per Wisconsin Requirements

A **Waiver of Subrogation** by endorsement for Business Automobile Liability, "**In favor of Milwaukee County**" is also required. A copy of the endorsement shall be provided.

Umbrella/Excess Liability

\$1,000,000 Per Occurrence

A **Waiver of Subrogation** by endorsement for Umbrella/Excess Liability "**In favor of Milwaukee County**" is also required. A copy of the endorsement shall be provided.

Professional Liability**

To include Certified/Licensed Mental Health and AODA Clinics and Providers \$1,000,000 Per Occurrence
and \$3,000,000 Annual Aggregate

Hospital, Licensed Physician or any other As required by State Statute
