This project will consist of a pool expansion from the existing 10,000 gallons increasing in size to 30,000 gallons (approx.). Included in this expansion is full 100% replacement/upgrade of Life Support System for increased water circulation/purification, increased visitor themed viewing experience (large viewing window) and the incorporation of shade structures for life betterment of the penguins.
