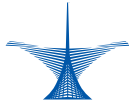

Dear Constituent,

Thank you so much for the opportunity to serve as your District 10 Milwaukee County Supervisor for the last year and a half. We've had some great celebrations and some challenges throughout the past 18 or so months, however, even on the most challenging of days, it is an honor to represent you on the County Board.

Since I was first elected in April of 2015, I have been named the Chairman of the Committee on Health and Human Needs which oversees the health and welfare of the residents of Milwaukee County. I also serve on the Finance and Audit Committee which is responsible for passing our \$1.4 billion budget.

The 2017 Budget was definitely challenging to say the least. Highlighted by the County Executive's Vehicle Registration Fee (Wheel Tax) and the renegotiation of the GO Pass, the board was able to cut the Wheel Tax in half (\$60 to \$30) and create a \$5 GO Pass fee that will be paid once every three years in addition to a \$1 per day unlimited ridership fee. The GO Pass fees will ease the budget constraints that the Milwaukee County Transit System is facing and will ensure that all residents continue to receive consistent, quality transportation.

I am very proud of the resolutions I have sponsored and cosponsored, including the appropriation of dollars dedicated towards safety measures and youth development in 53206 and other disparately impacted zip codes. I was honored to stand with Supervisor Sequanna Taylor who authored a resolution to improve domestic violence awareness and I was privileged to co-sponsor a \$15 living wage ordinance from Supervisor Marcellia Nicholson. I also supported a budget amendment that provides support for home healthcare workers who seek higher wages from their employers.
