Audit Committee to Review MCTS Governance Audit, Jail Corrective Actions, and UHC Contract Communications Timeline Reports

MILWAUKEE – The Milwaukee County Audit Committee will convene on Monday, June 8, at 3 pm to review multiple major audit findings reports and recommendations. This meeting will hear reports examining governance practices at the Milwaukee County Transit System (MCTS), updates on corrective actions related to the Milwaukee County Jail, and an informational report on the UnitedHealthcare (UHC) contract timeline.

- **Milwaukee County Transit System Governance Audit** – The Committee will review a newly completed audit [report](#) identifying opportunities to strengthen oversight, improve transparency, clarify governance roles, and enhance fiscal reporting within MCTS.
- **Milwaukee County Jail Corrective Action Update** – The Committee will receive an informational [status report](#) regarding the Office of the Sheriff's progress toward implementation of corrective action plan items stemming from Creative Corrections, LLC's external audit/evaluation of the Milwaukee County Jail.
- **Register of Deeds Audit Follow-Up** – The Committee will review a [status report](#) on the progress made toward implementing recommendations contained in a previous audit of the Register of Deeds Office.
- **UHC Contract Communications Timeline** – The Committee will receive an [informational report](#) containing documents related to Audit Services Division communications concerning the UnitedHealthcare contract.
