
RE: RELEASE OF MUNICIPAL COURT INFORMATION

IT IS HEREBY FURTHER DIRECTED that, the Municipal Court shall release this information to the Children, Youth, and Family Services upon request.

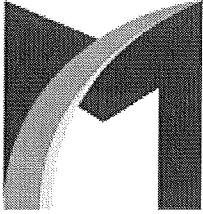
