I. Introduction

The 1st Judicial District's in-person hearings and jury trial recovery plan will continue to follow a multiphased approach. During each recovery phase, a limited number of courts will resume in-person hearings and jury trials. Prior to advancing to the next recovery phase, the court will review and consider current CDC, DHS and local public health authorities guidance as well as current local COVID-19 case data. Additionally, during each recovery phase, the policies and procedures included in this plan as well as juror processes, courtroom configurations and activities of each court, will be reviewed and assessed in consultation with the County and system partners. Changes to this plan that are necessary to protect and/or enhance the health and safety of employees, litigants and the public will be made as progression through each phase occurs.

The 1st Judicial District has weathered and navigated this pandemic together with system stakeholders. Unfortunately, COVID-19 new cases, the test positivity rate and hospitalizations continue to trend in the wrong direction. And, just over half of the city of Milwaukee residents are fully vaccinate. According to the state Department of Health Services (DHS), Wisconsinites who weren't fully vaccinated for the coronavirus were nearly three times as likely to get infected in July as fully vaccinated people, according to new state health data released in August 2021. And those who were less than fully vaccinated were nearly four times as likely to need hospital care and more than 10 times as likely to die. Public health experts have concluded that the Delta variant is extremely infectious (including breakthrough infections among vaccinated individuals); that large number of people who remain unvaccinated represent the majority of individuals who get sick enough to be hospitalized; and the increase in spread is due to the decrease in mask wearing and increase in physical interactions in close proximity with others.

The 1st Judicial District is carefully watching these numbers as it has always done and will continue its stepwise approach to the court's recovery efforts, knowing how essential it is to provide access to justice and manage the back log of cases. From day one of the pandemic, the 1st Judicial District has steadily increased its footprint while never having an outbreak in the courthouse, never contributing to the spread of the virus in the community nor increasing the numbers of individuals admitted to the hospitals and never having to reinstate mask mandates or other safety precautions when the Delta variant became a major threat to the community.

II. General Guidance

Only courtrooms approved by the Chief Judge shall be used for in-person hearings and jury trials.

Effective September 7, 2021, Criminal Division judges will conduct in-person hearings in their own courtroom. The only exception will be when a judge's courtroom is also being used as a shared

jury trial courtroom and trials are scheduled. In that case, the judge conducting in-person hearings will switch courtrooms with the judge scheduled to conduct jury trials.

1. The following courtrooms are authorized for in-person hearings and jury trials **effective September** 7, 2021:

- 2. Calendars listing judges and their jury trial courtrooms will continue to be created weekly and shared with key stakeholders.
- 3. The Chief Judge and county public health officials are also re-evaluating each criminal division courtroom and jury deliberation room to determine which courtrooms can accommodate jury trials. The decision to open additional jury trial courtrooms is forthcoming.

III. Judge and Court Staff Health

- 1. Regardless of vaccination status, judges and court staff will be required to wear face masks at all times in court buildings, courtrooms, jury rooms and any court-related spaces. The requirement for the wearing of face masks in the courtroom can be modified by the judge but only after the judge makes a record of the reasons for the decision.
- 2. Judges and court staff will practice physical distancing and appropriate hand hygiene as recommended by the CDC.
- 3. Court employees have been provided instructional material on how to wear face masks properly.
- 4. Judges and court staff who are experiencing any symptoms associated with COVID-19 shall stay home.
- 5. Judges and court staff shall follow any County self-quarantine policy in place at the time of travel.

IV. Scheduling

- 1. Cases will be scheduled for jury trial on Monday each week.
- 2. Effective October 20, 2021, the Domestic Violence and Misdemeanor divisions will schedule Wednesday jury trials.
- 3. Trials shall be scheduled at 8:30 a.m. or 1:30 p.m. using the voir dire schedule on page 3.
- 4. In the Criminal Division, jury trials involving defendants who are in-custody and have made a demand for a speedy trial or prompt disposition shall be given priority in scheduling.

5. The Children's Court Division, Civil Division, Criminal Division and Family Division shall create and distribute a set of policies and procedures to guide litigants concerning jury trials and other in-court proceedings.

V. <u>Health Safety Precautions</u>

- 1. There are signs posted informing the public that anyone with a fever, cough or other COVID-19 related symptoms is not to enter the building.
- Entry health status screening. All court system employees and visitors to the Courthouse complex and Vel R. Phillips Youth and Family must complete and receive a "green status" on the daily health screening before entry to the facilities will be allowed.

- 3. Jurors present a "green status" on the health screening before entry into jury assembly or courtroom. https://milwaukeecovid.sjc1.qualtrics.com/jfe/form/SV cU7jQuSH4Iac9PT
- 4. Mandatory Face Masks. All employees and visitors are required to wear a face to prevent the spread of COVID-19. There are limited health-related exceptions to this mandate. Masks and a hand sanitation station are available upon entry to the building.
- 5. Physical distancing. Appropriate 6' physical distancing is required at all times in the Courthouse complex, if possible. Waiting areas and elevator queuing areas are marked. Elevator capacity is limited to two non-family visitors. The stairways are available for use.

VI. Voir Dire & Empaneled Jurors

1. Jury panels sent to voir dire will be limited to the capacity of the voir dire spaces as follows:

• 400-Courthouse 30 Jurors

• 500-Courthouse 35 Jurors

• 620-Safety Building 35 Jurors

Zoofari Courtroom 34 Jurors

- 2. Panels will be announced and assembled maintaining proper 6' physical distancing, if possible. Floor markings have been placed to indicate proper distancing.
- 3. Once selected to serve on a jury, jurors will report directly to the courtroom or the jury room each day as directed by the judge.
- 4. Jurors will be instructed to monitor their health daily and to not report for service if they feel ill.
- 5. Before reporting for service each day, jurors must complete the health screening questionnaire.
- 6. Jurors who feel ill or answer "yes" to any health screening questions must immediately contact the court.
- 7. Jury deliberation rooms have been configured to provide 6' physical distancing, if possible.
- 8. Once a juror selects their seat in the deliberation room, it shall remain that juror's seat until the

jury panel is released by the judge at the conclusion of the trial.

- 9. Judges should remind jurors that masks must be worn at all times in the deliberation room.
- 10. Jurors not selected to serve on a panel should be sent back to jury management. Upon completion of service, jurors will be released and sent home.
