**RE: GUN COURT & HIGH INTENSITY DRUG TRAFFICKING AREA (HIDTA)
COURT CALENDAR EQUALIZATION**

IT IS HEREBY DIRECTED that effective January 1st, 2022, Chief Judge Directive 20-03 is rescinded.

IT IS HEREBY DIRECTED that, in order to effectuate equalization of the calendars in the Gun and HIDTA courts that the attached list of cases be immediately transferred from Judge David Feiss, Branch 46, to Judge Michael J. Hanrahan, Branch 4.


IT IS HEREBY DIRECTED that, effective January 1, 2022, in order to effectuate and maintain equalization of the calendars in the Gun and HIDTA courts that all felony cases involving individuals charged as either a defendant or co-defendant in Attempt Homicide, Recklessly Endangering Safety, Reckless Injury or other felony matters involving the discharge of a firearm shall be assigned to Judge David Feiss, Branch 46, and Judge Michael J. Hanrahan, Branch 4, according to the attached 2022 Gun/HIDTA Court Intake Schedule.

IT IS HEREBY DIRECTED that, all felony cases issued by the prosecutors assigned to the Milwaukee County District Attorney's Office High Intensity Drug Trafficking Area Unit shall continue to be assigned to Judge Michael J. Hanrahan, Branch 4.

IT IS HEREBY DIRECTED that, all substitutions against Judge David Feiss shall be assigned to Judge Michael J. Hanrahan, and all substitutions against Judge Michael J. Hanrahan shall be assigned to Judge David Feiss.

To maintain calendar equalization in the Gun and HIDTA courts, the Chief Judge reserves the right to issue administrative case transfer orders at any time.
