**RE: DISSOLUTION AND DISBURSEMENT OF CIVIL CALENDAR (E)

**Effective July 31, 2022:**

**IT IS HEREBY DIRECTED THAT**, the Civil Calendar (E) assigned to Branch 27, Judge Kevin E. Martens, shall be dissolved and the cases assigned to that calendar shall be disbursed as follows:

1. All jury trials scheduled between July 31, 2022 and December 31, 2022, all odd numbered cases, and select even numbered cases as set forth on the attached list shall be assigned to Branch 34, Judge Glenn H. Yamahiro, in Room 206 of the Courthouse.
2. All other even numbered cases assigned to Civil Calendar (E) shall be reassigned to the remaining eight (8) Civil Division Large Claim judges.



**IT IS FURTHER DIRECTED THAT**, the Civil Calendar (K) assigned to Branch 34, Judge Glenn H. Yamahiro, shall be re-assigned to Branch 23, Judge Lindsey Grady, as follows

1. All current PR (probate) and GN (Guardianship) cases.
2. All new PR and GN cases.
3. All new Individual at risk TRO/Injunction petitions.
4. All pending and new adoption (AD) petitions.
5. The re-assignment shall exclude any cases wherein a litigant substituted On Judge Grady and/or Judge Grady recused herself.

**IT IS FURTHER DIRECTED THAT**, the Civil Calendar (C) assigned to Branch 23, Judge Lindsey Grady, shall be removed from the civil intake draw.
