**RE: DISSOLUTION OF BRANCH 27 CIVIL CALENDAR (E) AND  
REDISTRIBUTION OF CASES**

**EFFECTIVE JULY 31, 2022:**

**IT IS HEREBY DIRECTED THAT**, Branch 27 civil calendar (E) shall be dissolved and the cases redistributed as follows:

- 1) Pending cases:
  - a. Odd-numbered cases and designated even-numbered cases (approximately 198 cases) have been assigned to Judge Glenn H. Yamahiro, Branch 34, pursuant to previous directive.
  - b. Remaining even-numbered cases with no prior substitution/recusal of Judge Hannah C. Dugan, Branch 31, shall be assigned to Judge Hannah C. Dugan, Branch 31.
  - c. Remaining even-numbered cases with a prior substitution/recusal of Judge Hannah C. Dugan shall be randomly assigned to one of the seven other large claims judges (Judges Connolly, Colon, Foley, McAdams, Rosa, Sosnay, Yang) under current chief judge substitution/recusal protocols.

2) Closed cases:

- a. Odd-numbered cases have been assigned to Judge Yamahiro pursuant to previous directive.
- b. Even-numbered cases with no prior substitution/recusal of Judge Hannah C. Dugan shall be assigned to Judge Hannah C. Dugan's calendar.
- c. Even-numbered cases with a prior substitution/recusal of Judge Hannah C. Dugan shall be randomly assigned to one of the seven other large claims judges calendars (Judges Connolly, Colon, Foley, McAdams, Rosa, Sosnay, Yang) under the existing chief judge substitution/recusal protocols.

**EFFECTIVE JULY 1, 2022:**

- 3) No further civil cases shall be assigned to Branch 27.
