EFFECTIVE IMMEDIATELY:


IT IS HEREBY DIRECTED THAT, Branch 37, Judge T. Christopher Dee pair with Branch 2, Judge Milton L. Childs Sr. to effectuate the case calendar reduction strategy in the felony criminal division as follows:

Effective July 30, 2022,

1. Cases attached hereto as Exhibit A shall be transferred from Judge Milton L. Child's calendar to Judge T. Christopher Dee's calendar if not closed.
2. All cases transferred shall be heard in person. Videoconferencing will only be allowed where a defendant is at Sandridge, MMHI or similar institutions and at the discretion of Judge Dee.
3. Substitutions on Judge Dee of cases from Judge Childs shall be assigned to Judge Laura A. Crivello, Branch 36. Judge Dee also has the discretion to return any case to Judge Milton L. Childs Sr.

- 4. Judge T. Christopher Dee also will handle spin jury trials available for any criminal felony calendar.
