**RE: REDISTRIBUTION OF CASES FROM JUDGE BRITTANY GRAYSON,

EFFECTIVE IMMEDIATELY:

IT IS HEREBY DIRECTED THAT Reserve Judge John Franke pair with Judge Brittany Grayson, Branch 16, to effectuate the case calendar reduction strategy in the felony criminal division as follows:

1. A new, temporary backlog reduction Felony Drug calendar (TF) shall be created and assigned to Reserve Judge John Franke. This calendar will not be added to the Felony Drug intake schedule.
2. Cases attached hereto as Exhibit A shall be transferred from Judge Brittany Grayson's Felony calendar (OF) to Judge John Franke's Felony calendar (TF).
