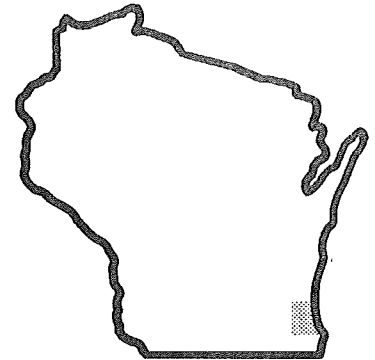

RE: **REDISTRIBUTION OF CASES FROM JUDGE JEAN M. KIES, BRANCH 45, TO JUDGE JEFFREY A. WAGNER, BRANCH 38, AND FROM JUDGE ELLEN R. BROSTROM, BRANCH 6, TO JUDGE JEFFREY A. WAGNER.**

EFFECTIVE IMMEDIATELY:

IT IS HEREBY DIRECTED THAT, Judge Jeffrey A. Wagner, Branch 38, pair with Judge Jean M. Kies, Branch 45, and Judge Ellen R. Brostrom, Branch 6, to effectuate the case calendar reduction strategy in the Homicide and Sexual Assault Division as follows:

1. Cases attached hereto as **Exhibit A - (AMENDED)** shall be transferred from Judge Jean M. Kies' s homicide and sexual assault calendar (KF) to Judge Jeffrey A. Wagner's homicide and sexual assault calendar (RF).
2. Cases attached hereto as **Exhibit B - (AMENDED)** shall be transferred from Judge Ellen R. Brostrom' s homicide and sexual assault calendar (JF) to Judge Jeffrey A. Wagner's homicide and sexual assault calendar (RF).
3. Substitutions against Judge Jeffrey A. Wagner in cases transferred from either Judge Ellen R. Brostrom or Judge Jean M. Kies shall be assigned randomly within the Homicide and Sexual Assault Division. Judge Jeffrey A.

Wagner has the discretion to return a case back to its previously assigned judge – Judge Ellen R. Brostrom or Judge Jean M. Kies.
