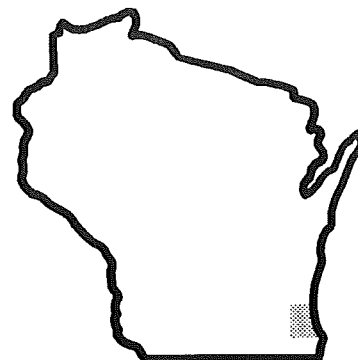

**RE: INTERIM JUDICIAL ROTATION – COURTROOM AND CALENDAR ASSIGNMENTS**


**Effective October 31, 2022:**
