Subject: **GENERAL ASSIGNMENTS TO RESERVE JUDGES**

WHEREAS: In order to provide for the effective management of case flow through the First Judicial Administrative District, and pursuant to Wisconsin Statute 751.03(3) and Supreme Court Rule 70.19 and 70.23(2), this court hereby issues an order to assign all reserve judges having a General Assignment in the district to cover any branch of circuit court within District 1. Reserve judges shall provide coverage for other branches as the need arises and the proper and timely conduct of court business may require.


WHEREAS: This order shall cover instances of both routine and emergency judicial absence, including but not limited to attending judicial education, family medical leave, vacation, or absence produced by other circumstances.

WHEREAS: This order also assigns reserve judges with a General Assignment Order for purposes of relieving congestion, to expedite litigation and otherwise to assist in any branch of the circuit court.

WHEREAS: The District Court Administrator shall be notified and shall determine approval of any assignment of cases to a reserve judge from a branch other than the one to which the reserve judge assignment order authorizes.

IT IS THEREFORE ORDERED that these assignments shall be and are in effect from January 1, 2023 through December 31, 2023.
