
EFFECTIVE IMMEDIATELY:

IT IS HEREBY DIRECTED THAT, a certain number of Judge Brittany Grayson's cases on the attached Exhibits A & B be distribute to Judge T. Christopher Dee and Reserve Judge John Franke to effectuate the case calendar reduction strategy in the Drug Court as follows:

1. Cases attached hereto as **Exhibit A** shall be transferred from Judge Brittany Grayson's Felony Drug Calendar (OF) to Judge T. Christopher Dee's calendar (SF).
2. Cases attached hereto as **Exhibit B** shall be transferred from Judge Brittany Grayson's Felony Drug Calendar (OF) to Reserve Judge John Franke's Felony calendar (TF). **(Amended – cases listed on Exhibit A deleted from Exhibit B.)**
