AGREEMENT
BETWEEN

TECHNICIANS, ENGINEERS AND ARCHITECTS OF
MILWAUKEE COUNTY

This Agreement, made and entered into by and between the County of Milwaukee, a municipal body corporate, as municipal employer, hereinafter referred to as “County” and Technicians, Engineers and Architects of Milwaukee County, as representatives of employees who are employed by the County of Milwaukee, hereinafter referred to as “Association”.

WITNESSETH

In consideration of the mutual covenants herein contained, the parties hereto do hereby mutually agree as follows:

PART 1

1.01 RECOGNITION

The County of Milwaukee agrees to recognize and herewith does recognize Technicians, Engineers and Architects of Milwaukee County as the exclusive collective Bargaining agent of behalf of the Employees of Milwaukee County in accordance with the certification of the

1 Wisconsin Employment Relations Commission, as amended, in respect to wages, pursuant to
2 Subchapter IV, Chapter 111.40, Wisconsin Statutes.

4 1.02 EMPLOYEE DEFINED

5 Wherever the term “employee” is used in this Agreement, it shall mean and include only those
6 employees of Milwaukee County within the certified bargaining unit represented by the
7 Association.

9 1.03 DURATION OF AGREEMENT

10 (1) After ratification by the parties the provision of this Agreement shall become
11 effective January 1, 2015, unless otherwise herein provided. Unless otherwise
12 modified or extended by mutual agreement of the parties, this Agreement shall expire
13 on December 31, 2015.

14 (2) The initial bargaining proposals for a successor agreement shall be submitted by the
15 Association prior to August 15, 2015. The initial bargaining proposals shall be
16 submitted by the County prior to September 15, 2015. The first scheduled
17 negotiations session shall be held no later than October 15, 2015. Thereafter,
18 negotiations shall be carried on in an expeditious manner and shall continue until all
19 bargainable issues between the parties have been resolved.

20 (3) The timetable is subject to adjustment by mutual agreement of the parties consistent
21 with the progress of negotiations.

The provisions of this Part 2 shall become effective in accordance with Part 1 unless otherwise provided.

2.01 WAGES

(1) Effective Pay Period 14, June 21, 2015, the wages of the bargaining unit employees shall be increased by one and one-half percent (1.5%).


(2) If any non-public safety collective bargaining unit of Milwaukee County receives a base salary increase greater than one and one-half percent (1.5%) in calendar year 2015, the Association shall have the right to request re-opening negotiations over Section 2.01 (1) of this Agreement.
