

Milwaukee County Personnel Review Board

Meeting Minutes – March 21, 2023

I. Roll Call

Board Vice President Phoebe Williams called to order the regular meeting of the Personnel Review Board at 9:00 a.m. on Tuesday, March 21, 2023. The meeting was held telephonically.

The following Board Members were present: Ms. Phoebe Williams, Mr. Daniel Dennehy, and Mr. Greg Renz. Mr. David Kern was excused. Ms. Yovira Moroney was absent.
